



Banning High School

Responsibilities of Adult Students



Overview

Eighteen-year-old or older students are legally recognized as adults. Except as noted below, policies and procedures set forth in the Banning High School Parent/Student Handbook will apply to all students, regardless of their attainment of the age of majority:

- ★ Students 18 years and older may have the same privilege as their parents/guardians as it relates to access to their student records.
- ★ Parents/guardians may be permitted access to their child's education records, without the student's consent, under the following circumstances: a) the student is a dependent for federal income tax purposes; b) the disclosure is necessary to protect the health, welfare, or safety of the student or other individuals.
- ★ Students 18 years and older may represent themselves during disciplinary, academic, and/or attendance conferences and be the addressee for their academic grade reports.
- ★ Students 18 years and older involved in a physical altercation or assault may be arrested, as the altercation may also involve a minor.
- ★ Students 18 years and older involved in the possession or use of drugs or alcohol may be arrested and placed into custody at an adult correctional facility.
- ★ Students 18 years and older that are grossly credit deficient may be dropped and recommended to attend an appropriate adult education program.
- ★ Students 18 years and older may sign themselves in and out of school and may verify their own absences. All school attendance standards continue to apply to students regardless of their age.
- ★ Students 18 years and older may forfeit sign out privileges as a result of any of the following: failure to adhere to rules, regulations, and policies outlined in the Banning High School Parent/Student Handbook, excessive tardies, excessive absences, frequent early sign outs, and a pervasive negative student discipline record.
- ★ Eligible students who wish to assert these rights will register their intent on the appropriate form in the high school attendance office. Until such time as the eligible student registers this intent, school officials will not apply the above exceptions to school policies and procedures.
- ★ A copy of the completed form will be provided to the student's parent/guardian. The signed original form will be retained in the attendance office.

- I may represent myself during disciplinary, academic, and/or attendance conferences and be the addressee for their academic grade reports.
- If involved in a physical altercation or assault I may be arrested, as the altercation may also involve a minor.
- If involved in the possession or use of drugs or alcohol I may be arrested and placed into custody at an adult correctional facility.
- If I am grossly credit deficient I may be dropped and recommended to attend an appropriate adult education program.
- I may sign myself in and out of school and may verify my own absences. All school attendance standards continue to apply regardless of my age.
- I may forfeit sign out privileges as a result of any of the following: failure to adhere to rules, regulations, and policies outlined in the Banning High School Parent/Student Handbook, excessive tardies, excessive absences, frequent early sign outs, and a pervasive negative discipline record.
- I further understand that if I am found in violation of this agreement through my actions and/or abuse, my privileges will be revoked effective immediately. I understand this action to be necessary in order to maintain high professional standards and the integrity of Banning High School.
